NOTICE IS HEREBY GIVEN that an annual general meeting (the "**Meeting**") of holders of common shares (the "**Common Shares**") of Outback Goldfields Corp. ("**Outback Goldfields**" or the "**Company**") will be held at Suite 700, 1090 West Georgia Street, Vancouver, British Columbia on Thursday, January 26, 2023, at 11:00 a.m. (PST).

At the Meeting, Shareholders will be asked to:

- 1. fix the number of directors of the Company at five (5) persons;
- 2. elect five (5) directors of the Company for the ensuing year;
- 3. appoint D&H Group LLP as the Company's auditor for the ensuing year and authorize the directors to determine the remuneration to be paid to the auditor;
- 4. confirm the Company's stock option plan, as required annually by the policies of the TSX Venture Exchange; and
- 5. transact such other business as may property be put before the Meeting.

At the Meeting, Shareholders will also receive and consider the audited financial statements of the Company for the financial year ended June 30, 2022, together with the auditors' report thereon.
